**IV. COMP-007 - Farish Street Area Cultural Mixed Use District (FSA-CMUD) and Relative Text Amendments Proposed Farish Street Revitalization Comprehensive Rezoning**

**Petitioner:** City of Jackson/ Department of Planning & Development/Zoning Division

**Requesting:** Comprehensive Rezoning of the Farish Street area and the relative text amendments to the City of Jackson Official Zoning Ordinance as adopted on May 29, 1974 and subsequently amended to establish the Farish Street Area Cultural Mixed Use District (FSA-CMUD).

**Planning Board Vote:** **(Motion to Approve) (9) in favor (0) Opposing**

**Planning Board Recommendation:** **Approval of the Request for a Comprehensive Rezoning of the proposed Farish Street Area the creation of the relative text amendments to the Zoning Ordinance.**

**Public Input:** Representatives from the community, Monica Butler, Frank Figgers, Jimmie Stewart, Gladys Stewart, Amy Lancaster, George Stewart and all spoke in support of the case. Mary Cole Washington was in support of the case but had concerns about communication relative to the community.
