Erian Sutton, 23, has been charged with murder, aggravated assault, and shooting into an occupied vehicle. The second case concerns a shooting on July 5, 2025, that resulted in the death of 23-year-old Gabriel King. Juquavion Clark, 17, has been charged with murder, while Cameron Russell, 24, Daniel Taylor, 22, and another 17-year-old are charged with accessory after the fact.
