

1. Answers to questions for the RFP for Municipal Solid Waste Disposal Services

1. Are there any planned additions or changes to the City's recycling or solid waste collection programs that could change the amount of solid waste collected by the City's residential solid waste collection contractor and delivered for disposal?

A. No.

- 2. Are fuel surcharges and environmental fees allowed in addition to the disposal pricing?

 A. Fuel surcharges and environmental fees should be reflected in the disposal pricing. Any increases in the cost of fuel or environmental fees would be reflected the annual cost adjustment.
- 3. Is a minimum permitted capacity (i.e. cubic yards, tonnage or remaining life) required?
 - A. There is no minimum permitted capacity. However, remaining life of the landfill based on annually estimated use would be a factor in evaluating the proposal.
- 4. Is an Equal Business Opportunity Plan for minority and/or female business suppliers required?
 - A. There is no requirement for an EBO Plan.
- 5. Under Section 1.3 "Background" the RFP states that the current agreement with Waste Management (WM) will expire on October 31, 2025. Yet the copy of the agreement that was supplied as Appendix A of the RFP clearly indicates in Section III "Term of Contract" on page 7 that the current term of the WM contract does not expire until October 31, 2026, at the earliest.
 - A. As a result of a settlement under another contract with WM, the expiration for the first extension was set a year earlier, October 31, 2025. Please see Appendix A.1 as attached.
- 1. Do you want a rate for special waste?
 - a. Yes, please provide a rate for special waste. Currently, the City does not have special waste for disposal. However, this may change in the future. This rate will not be used in the evaluation of the proposals.
- 2. If so what special waste streams and expected volumes would be brought, example such as Liquids, sludges, contaminated soil etc.
 - a. Sludge
