Her death was the result of a violent stabbing, and her long-term partner, Robert Bass, was initially arrested and charged in connection with her murder. Despite multiple efforts over the years, Gina's family has not been able to obtain clarity or closure regarding the legal outcome of the case. They were not notified of key decisions made during the process, and prior attempts to seek information have left them feeling dismissed and disrespected. This letter is a formal request for public records pursuant to the Mississippi Public Records Act (§25-61-1 et seq.). Specifically, we are requesting: 1. The case docket or summary of State of Mississippi v. Robert Bass, including: * Charges filed * Dates of hearings * Bond information * Final disposition (e.g., dismissal, no true bill, indictment, plea, etc.) 2. Any publicly available court orders or decisions confirming the case outcome. Records that would contain police report, photographs of the scene, 911 call, reports from ambulance service. We are not requesting any confidential material or sealed records — only public documents that should be available under state law. If possible, please provide the documents electronically via email. If any fees apply, please notify us in advance. Gina's family deserves access to basic information about how her case was handled. This request is part of an effort to preserve her memory, advocate for justice, and understand how such a tragic case ended without resolution.
