Following her death, he kidnapped her two children, 4-year-old Erin Brunett and 6-year-old Jalie Brunett, and transported them to Mississippi in the mother's vehicle. Callihan returned to Louisiana to retrieve a co-conspirator before bringing the children to a residence in Jackson, Mississippi. During this time, the 6-year-old was sexually assaulted, and the 4-year-old was fatally suffocated by the defendant. Callihan subsequently confessed to these acts. He pleaded guilty to federal charges on August 12, 2025, and is scheduled to be sentenced on November 19, 2025.
