Short answer up front: I couldn't find any online Hinds County court docket or digitized news article that matches a 1993 shooting on Sunset Drive where a married woman named Beverly (husband Marty) — with a 10-month-old and a 3-year-old in the home — was shot inside her house and survived. My searches of public court indexes, Mississippi appellate records and digitized Clarion-Ledger/newspapers.com pages turned up no accessible trial dockets or news stories that match those details. Why I couldn't find a match online Hinds County trial dockets from the early 1990s are often not digitized or searchable by street address; online systems normally require a party name or case number. The circuit/county clerk offices would need to run a paper-index search for 1993 records if they haven't been scanned. Local newspaper coverage (Clarion-Ledger) from 1993 is commonly available only as scanned images on newspapers.com or on library microfilm; many of those images are paywalled or not text-searchable, so an article can exist but not surface in free web searches. What I searched (summary) Party-name and address searches across Mississippi appellate sites, Hinds County court pages, and newspapers.com/Clarion-Ledger snippets (1990–1995). The best matches I found were general references to "Sunset Drive" in Clarion-Ledger pages and some appellate dockets that name parties called Beverly in Hinds County — none linked to a 1993 Sunset Drive shooting of a Beverly with the family details you gave.
