I would like to respectfully request the case files related to the investigation of Daniel Callihan in connection with the deaths of Callie Brunett and Erin Brunett. On June 12, 2024, Callie Brunett (age 35) was found deceased with multiple stab wounds inside her mobile home in Loranger, Louisiana, after family members became concerned for her welfare. Her two daughters were missing from the residence, prompting an Amber Alert and a multi-agency search.
