Code Ann. § 25-61-1 et seq., I am requesting access to and copies of public records related to the following individuals and incident: Suspect Name: Treylin Dontrell Sojourner Victim Name: Marvin Houck Jr. Date of Incident or Crime: July 17, 2024 Time of Incident: Approximately 6:00 a.m. Location of Incident: Pine Tree Drive near Pine Ridge Drive / Pine Lawn Place, South Jackson, Mississippi Nature of Case: Fatal shooting; during an altercation while the two men were walking together in South Jackson, Sojourner struck Houck in the back of the head with a firearm, causing a fatal gunshot wound to the head. Houck's body was discovered collapsed in the roadway by two passersby walking a dog. Sojourner was charged with Murder, subsequently pled guilty to second-degree murder, and was sentenced to 30 years in prison in May 2026 by the Hinds County District Attorney's office. The case is fully adjudicated. Requested Records: Interrogation footage or confession footage of the suspect or subject in video format (including any recorded custodial interviews or statements given by Treylin Dontrell Sojourner to Jackson Police Department investigators or assisting agencies). Crime scene or relevant photos documenting Pine Tree Drive near Pine Ridge Drive and any physical evidence recovered at or near the scene.
